

Terms and Conditions of the Flexcon PA – Flexcon PA AutoFill Campaign

These conditions apply to the Flexcon PA – Flexcon PA AutoFill campaign, hereinafter referred to as “the Promotion”, which is organised by Flamco B.V., with its registered office at Amersfoortseweg 9, 3751 LJ in Bunschoten, hereinafter referred to as: “Flamco”.

Article 1 General

- 1.1 The Promotion concerns participation in the Flexcon PA – Flexcon PA AutoFill Campaign that makes it possible to win a prize as described in article 4. An explanation concerning the operation of the Promotion is provided in article 5.
- 1.2 Every natural person with a valid driver’s licence has the right to participate in the Promotion.
- 1.3 Employees of Flamco (including subsidiaries, companies affiliated with it or companies that have been hired) are excluded from participation.
- 1.4 Participation in the promotion means that you agree to the content of these terms and conditions of the promotion as well as all decisions made by Flamco to guarantee that this Promotion takes place properly.

Article 2 Information

- 2.1. If you participate you will be requested to provide personal data such as your name, telephone number and e-mail address.
- 2.2. These personal details will be used by Flamco for the purpose of processing your application. By entering your personal data you also authorise Flamco to send you product information, special offers and other information concerning Flamco products by e-mail or in another manner.
- 2.3 In accordance with the provisions of the Personal Data Protection Act, you have the right, at all times, to remove your data from the Flamco database by sending an e-mail message to Flamco or via the internet link for this purpose that can be found at the bottom of Flamco e-mails.

Article 3 Promotional period

- 3.1 The start date of the Promotion is 1 September 2017, the promotions runs until June 30, 2018.

Article 4 Prizes

- 4.1 The prize that can be won is what is known as a 'Drive Experience Voucher'. This allows the winner in various countries to choose from several driving experiences.
- 4.2 After the promotional period has ended, Flamco will raffle up to 100 Drive Experience Vouchers, hereinafter referred to as "the Prize", among the participants.
- 4.3 Flamco reserves the right to award an alternative prize.
- 4.4 Any Prize this won cannot be exchanged for cash or cash equivalents.
- 4.5 In case of ineligibility, or any other reason why the Prize is not redeemed, the prize will revert to Flamco without any form of payment or compensation to the winner or his/her relatives or heirs.

Article 5 Operation of the Promotion

- 5.1 Participation in the Promotion is only active when:
 - the participant has registered on the website www.flamcogroup.com/drive
 - the participant has entered the participation code of the product purchased as well as the required personal information
 - the participant has uploaded the proof of purchase of Flexcon PA or Flexcon PA AutoFill.
- 5.2 Registering is possible until July 31, 2018
- 5.2 Participation is possible as a result of the purchase of a Flexcon PA or a Flexcon PA Autofill and retaining from the packaging the promotion coupon on which the Promotion and the related website information is stated.
- 5.4 The winners are notified by Flamco during August 2018. The Prize is sent by post or will be delivered by a Flamco employee. The Prize reverts to Flamco as described in article 4.4 if it cannot be delivered or awarded for any reason.
- 5.5 Flamco is not responsible for delivery by mail.

Article 6 Flamco's rights

- 6.1 Flamco reserves the right to end, interrupt or change the Promotion and any other part of the website as it sees fit and without prior notification if such is required by circumstances.
- 6.2. Flamco will make a unilateral or binding decision in cases not provided for in these terms and conditions.
- 6.3 Flamco reserves the right to exclude a participant from the Promotion if the participant provided or attempted to provide incorrect, incomplete or misleading information or committed fraud in any other way.
- 6.4 Every participant declares by participating in the Promotion that he/she will cooperate at Flamco's request in promotional activities (including the awarding of the prizes) relating to the Promotion, without Flamco being obliged to pay any compensation in connection therewith.

Article 7 Liability and indemnification

- 7.1 Flamco, the auxiliary persons and/or third parties engaged by it are not liable for any loss, direct and/or indirect, which arises from or is related to the Promotion in any other way.
- 7.2 More specifically, Flamco, the auxiliary persons and/or third parties engaged by it are not liable for any loss, direct and/or indirect, caused by or in any other way related to the alteration, interruption or termination of the Promotion.
- 7.3 Flamco, the auxiliary persons and/or third parties engaged by it are not liable either for any additional costs you may have to incur in connection with the participation in the Promotion.
- 7.4 When accepting the Prize, the winner commits to the general terms and conditions of the organisation that will implement the Prize.

Article 8 Complaints or disputes

- 8.1 There will be no correspondence regarding the outcome. Any other complaints or requests may be addressed in writing to Flamco Group, attn. the Marketing department, PO Box 502, 3750 GM Bunschoten and such within at most 1 month after the end of the Promotion. The postmark serves as evidence. Any complaint or request for information sent after this term or that was not sent by post shall not be considered.
- 8.2 This Promotion is governed by Dutch law. The Amsterdam District Court has exclusive jurisdiction to hear disputes.
